Fin CEN Report 114

U.S. citizens who have a financial interest in or signature or other authority over any "financial accounts" in a foreign country (Canada) are required to make a separate filing if the aggregate value of these accounts exceeded \$10,000 at any time during a taxation year. Note: the \$10,000 threshold does not apply to each account separately. For example if you have 6 accounts that all had \$2,000, each bank account may not exceed \$10,000, but the sum of the accounts is \$12,000 and would therefore still require an FBAR filing.

- Investment Accounts
- RRSP
- TFSA
- Corporate Accounts with signing authority
